SC00TF0X's Terms of Service [Effective as of 9/4/2020]

By commissioning SC00TF0X, you acknowledge your agreement to these Terms of Service.

ABOUT THE SERVICE

It is my goal to create art that my customers love, as I create art of their characters that are near and dear to their hearts.

I ask that all commissioners carefully read the current price sheet before commissioning so they are certain of what they are paying. I will usually take no more than 5 commissions weekly, and most often the piece will be finished in no more than two weeks.

As of now, my work is done fully digital, and is SFW ONLY.

COMMISSIONING ME

You are to provide a clear photo reference. (no random images of your character unless they are clear and provide necessary information, no photos of the character's fursuit, etc.).

For REFERENCE SHEET commissions, if you do not already have a previous and accurate reference sheet, you are to provide any artwork/photos you may have of them, clear text description of your character's physical details, as well as objects they are associated with, outfits they wear, etc. You may be thorough, but if it does not help with the process of creating a clear and precise ref sheet, information may be disregarded.

WIP(Work in Progress) photos will be available for every commission type EXCEPT artistic freedoms.

The completion time for individual commissions varies, but should not exceed 1 month. In the event of an emergency, commission completion may be extended to 3 months or refunded. In the event of an emergency or life complications on our end, SC00TF0X will notify you ASAP and refund you fully or partially depending on the circumstances.

REFUND POLICY:

If there is an emergency, let me know as soon as possible and we can discuss a full or partial refund depending on how much work has been completed.

If there is anything I can do to make your commission better, do not hesitate to ask! It is very important to me that you get something you are pleased with and I will do the best I can to make any changes needed. Once work is complete, refunds will not be issued whatsoever. Any chargebacks will result in being blacklisted indefinitely. I hold every right to cancel and refund a commission at any time.

USE RESTRICTIONS

It is expected that you work alongside me in a fairly timely manner. If I decide that you have been absent/unresponsive for too long(5 months, for example), your commission may be disregarded and you will be removed from the queue.

You must be at least 18 years old to commission me.

If you are not 18 years or older, you will be refused your commission and you may be blacklisted if you lie about your age/block avoid/use your parents to try commissioning me again.

I only accept payment through PayPal, Venmo, or Cashapp.

If at any time you exhibit rude or inappropriate behavior, I reserve the right to decline your commission and potentially block and/or blacklist you from commissioning me again.

You agree that you will not under any circumstances:

- · use the artwork from your commission for any reason other than its intended purpose(ex: selling merchandise featuring the artwork) without the explicit permission from me
- · issue a refund when work has already started on your commission(doing so will immediately put you on a public blacklist)
- · use the artwork for any unlawful purpose or for the promotion of illegal activities
- · attempt to harass, abuse or harm me during the commission process
- · interfere or attempt to interfere with the functioning commission process

COPYRIGHT/USAGE POLICY

I, SC00TF0X, hold every right to the artwork produced. I am able to use the copyrighted artwork to:

- · promote myself within any place, website, or otherwise;
- · publish books
- · display/print anywhere to my liking.

You, the customer, are given the rights to:

- · print the copyrighted artwork on any object, as long as it is not used maliciously
- · claim rights to their character(s) that are featured in the artwork

· use the artwork to promote themselves(no permission is required as long as proper credit is given to SC00TF0X)

You acknowledge and agree that I, SC00TF0X, retain ownership of all intellectual property rights of any kind related to the original artwork. Commercial use of my artwork without permission may result in being blacklisted and/or blocked. Removal of watermarks/signatures or altering the artwork without the explicit consent of SC00TF0X may also result in the same consequence.

COMMERCIAL RIGHTS

In order for you to obtain commercial rights over a piece of my artwork, it will be a one time payment, two times the original commission price. The commercial rights allow you to:

- · Make and sell merchandise using the artwork
- · Change the artwork to your liking

These rights still require the artist's credit for usage, even if altered or edited.

USER AGREEMENT

We may use your social media direct messages or email address(if provided) to send you information about your commission or send you the artwork. You may opt out of the email and instead receive artwork through direct messages on social media, however we think it is best to use telegram, discord, or email in order to receive the highest resolution.
